The Centre is seeking 1 Course Instructor for the following course: CRI210H1S - Criminal Justice

Closing Date: Feb. 11, 2025

Course description: An introduction to the Canadian criminal justice system. The institutions established by government to respond to crime and control it; how they operate, and the larger function they serve; including the role of the police, the trial process, courts and juries, sentencing, imprisonment and community corrections.

Minimum Qualifications: Successful candidates should have or be near completion of their Ph.D in Criminology and Sociolegal Studies.

Preferred Qualifications: PhD in progress with ABD (all-but-dissertation) status conferred in Criminology and Sociolegal Studies.

Relevant Criterion: Past teaching experience is the more relevant criterion than the need to acquire experience in respect of this posted position.

Duties: This course will be delivered online. All normal duties related to the design, administration and teaching of a university credit course, including preparation and delivery of course content; supervision of teaching assistants; development, administration and marking of assignments, tests and examinations; calculation and submission of grades to university officials; holding regular student office hours and maintaining reasonable availability for student contact.
