How notions of different types of masculinity and femininity are embedded in and influence both the operation of the criminal justice system as well as criminal behaviours. The regulation of gender and sexuality through the criminal law and through crime.

Qualifications: PhD in progress with ABD (all-but-dissertation) status conferred from the Centre for Criminology and Sociologal Studies.
