The Centre is seeking 1 Course Instructor for the following course: CRI491H1S Advanced Topics in Criminology and Sociolegal Studies (Topics: Making and Unmaking International Law)

Closing Date : October 14, 2022

Course description: This course explores the making, contestations and unmaking of the international criminal law with a focus on the concepts, principles, core tenets and politics of international justice. By exploring the principles and challenges with international criminal justice in the contemporary period we will explore the spheres of engagement, contestations, forms of instrumentalism and affective expressions that are part of it. The class offers students an opportunity to learn about and critically reflect on the processes and purposes of law making and to explore the processes, politics, and ethics by which law is made and justice determined historically and in the contemporary period.

Minimum Qualifications: PhD in progress with ABD (all-but-dissertation) status conferred from the Centre for Criminology and Sociolegal Studies.

Preferred Qualifications: None

Relevant Criterion: The need to acquire experience is the more relevant criterion than past teaching experience in respect of this posted position.

Duties: All normal duties related to the design, administration and teaching of a university credit course, including preparation and delivery of course content; supervision of teaching assistants; development, administration and marking of assignments, tests and examinations; calculation and submission of grades to university officials; holding regular student office hours and maintaining reasonable availability for student contact. The mode of instruction for this course is expected to be in-person. However, if this changes for any reason, you will be provided with as much advance notice as practicable.
