The Centre is seeking 1 Course Instructor for the following course: CRI493H1 Advanced Topics in Criminology and Sociolegal Studies (Topics: Regulation and Oversight of the Criminal Justice System)

**Closing Date :** March 3, 2023

**Course description:** An introduction to the study of crime and criminal behaviour. The concept of crime, the process of law formation, and the academic domain of criminology. Theories of crime causation, methodologies used by criminologists, and the complex relationship between crime, the media and modern politics.

**Minimum Qualifications:** Successful candidates should have or be near completion of their Ph.D in Criminology and Sociolegal Studies.

**Preferred Qualifications:** PhD in progress with ABD (all-but-dissertation) status conferred in Criminology and Sociolegal Studies.

**Relevant Criterion:** Past teaching experience is the more relevant criterion than the need to acquire experience in respect of this posted position.

**Duties:** This course will be delivered online. All normal duties related to the design, administration and teaching of a university credit course, including preparation and delivery of course content; supervision of teaching assistants; development, administration and marking of assignments, tests and examinations; calculation and submission of grades to university officials; holding regular student office hours and maintaining reasonable availability for student contact.
